Scope of work for Civil Work *CW Airport 1 : Works- Reconstruction of Runway Mutiara Sis Al Jufri Airport in Palu*, *Central Sulawesi Province* .The works consist : Runway Area Works : 2,500 x 60 m²; Box Culvert Works : 29 x 90 m²; Helipad Works : 30 x 30 m²; Geotechnical Works : 250 x 60 m²; AFL and Electrical Works : 3,600 x 300 m²
- 3. Open competitive bidding with the national advertisement will be conducted in accordance with ADB's <u>single stage</u>: one envelope <u>without prequalification</u> procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
